**Privacy Notice For Pupils 2023/2024**

Ipswich High School is a proprietorial school owned by Ipswich Education Limited (IEL), whose Board has the legal responsibility to ensure that all regulatory requirements are met. This means that the Proprietorial Board has a role that is different to many independent schools. It is the role of the Proprietorial Board to provide the school with strategic guidance and oversight. The Proprietorial Board, therefore, have powers of scrutiny and are enabled to make recommendations for change and improvement. The Proprietorial Board are supported by voluntary advisors who will offer their advice as a "critical friend". Board meetings are held every term.

## Categories of Information

The school collects and processes a range of information about its pupils. This includes:

- Personal information (such as name, unique pupil number and address)
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility)
- Attendance information (such as sessions attended, number of absences and absence reasons)

- Previous school history and future school choice
- Family names and contact details
- Financial information for Bursary means-testing requirements
- Parental consents
- Passport, nationality and visa information
- Visits made to the school prior to admission
- Medical information
- Special Educational Needs information
- Assessment information
- Behavioural information
- Child protection and safeguarding information
- Pastoral information
- Careers related information such as: future career path choices, psychometric profiling, attendance to careers events and work experience options.
- LRC related information such as: resources borrowed, reserved, requested, reviewed and overdue.
- Final destination of post-16 students.

## **Why We Collect and Use This Information**

We use the pupil data:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care
- to assess the quality of our services
- to comply with the law regarding data sharing
- to safeguard and promote the welfare of pupils
- to fulfil our contractual and other legal obligations
- to provide additional activities for pupils, for example, activity clubs and educational visits
- to protect and promote our interests and objectives - this includes fundraising

- Financial awards – e.g. bursary offers
- Missing In Education legislation
- Child Protection
- Safeguarding
- UKVI stipulations and requirements
- To support pupil career paths and future options
- To support pupil literacy and reading for pleasure

## **The Lawful Basis On Which We Use This Information**

We collect and use pupil information under section 537A of the Education Act 1996, and section 83 of the Children Act 1989. We also comply with Article 6(1)(c) and Article 9(2)(b) of the General Data Protection Regulation (GDPR).

## **Collecting Pupil Information**

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

We may acquire Personal Data in a number of ways including, without limitation, the following:

- parents of pupils may provide us with Personal Data about themselves or their family in correspondence, forms, documents, during discussions with staff, and through our website;
- we may acquire Personal Data from other parents, or from people outside of the community who know parents or from the pupils themselves; and
- we may acquire Personal Data from third parties such as schools and nurseries, public authorities, public sources or from commercial sources such as credit reference agencies.

## **Storing Pupil Data**

We hold pupil data in accordance with our data retention policy which can be found on the school website.

## **Who We Share Pupil Information With**

We routinely share pupil information with:

- Schools that the pupils attend after leaving us, via DfE
- Schools where pupils apply to, via reference
- Our local authority
- The Department for Education (DfE)
- United kingdom Visas and Immigration
- Local county council (Suffolk County Council and Essex County Council as appropriate)
- Previous and future school/educational providers
- Exam boards
- Parents, guardians and sponsors
- National Health Service and health care providers including Child and Adolescent Mental Health Services (CAMHS)
- Our independent careers adviser
- Companies providing workplace placements

## **Why We Share Pupil Information**

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

## **Data Collection Requirements**

## **The National Pupil Database (NPD)**

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes.

This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

- claim compensation for damages caused by a breach of the Data Protection regulations
